<u>Old Business</u>: Input from OA Reps and members discussing the future of the OA office/conference room. Input received:

Monday WB: consensus was to close the office. (Susie) 1 abstained, 11 attended, more than 5 voted.

Wednesday Living in Solution: consensus to close the office. (Mary S.) unanimous, 8

Friday Ferndale: consensus keep the office open (Sue S., reporting for Paula) 9 people, 6 open, 1 close, 2 neutral

Detroit: 6 unanimous to keep open (Pam)

10 a.m. Celtic Cross: 5 people voted unanimously to close (Pina)

St. Mary's: 7 people, 4 open, 1 to close, 2 abstained (Carol U.)

Wed. night: 7 people, 2 abstain, 1 open, 4 close (Verna)

Monday Ferndale: 1 for closing, 4 open (Bobbi)

Wed. B'ham in-person, 9-10 a.m.: all agree to keep it open for near-term future (Catherine) Monday Tue Thurs Ferndale: – no vote, just informed (Sue)

St. Efrem: – consensus of 4, 3 to close, 1 abstain Ginny Sue M.

Note: It's possible that people who go to several meetings weekly may have voted several times.

Discussion followed, with Barbara suggesting we wait until the dust settles on face-to-face meetings, with three meetings coming back in person at the office. We only have 25% of 42 meetings reporting. Pamalar said no decision could be made now, that we would do the three-month rental period and return to this discussion in the next few months. More meetings need to weigh in.

Lynn reports about options from the landlord: We can go to a quarterly lease agreement beginning in May. There's been no raise in rent since 1997 when he bought the building. Smaller offices are \$500 a month, ours is \$600 and would rent for more now. Storage – no place in that building for storage, would need an outside unit, if needed.

There was an appeal to OA members to consider service to fill the above vacant committee positions.

<u>New Business</u>: Annual presentation of the GDI budget, for the new Fiscal Year beginning June 1, 2022 by Lynn H., who proposes two budgets. (Refer to budget sheets she turned in.)

• Budget A: preapproves anything we know we have to pay; anything that comes up not in budget goes back to the Intergroup for approval.

• Budget B: fixed with some flexible costs.

Need to vote on which budget so we can send to meetings for member review.

Question:

Pina: We did make donations to Free Conference Call from Intergroup. According to traditions, we should pay what we think as a donation. Should we build something into the budget? Lynn: Currently, several months ago, Intergroup decided to pay a set amount to FCC, but that could not be set up as a monthly amount. Comes out of my credit card. It's my contribution.

Vote:

A call for 15 more minutes of discussion was approved.

- Bobbi proposes Budget A. Sue seconds. 3 for Budget A.
- Barbara proposes Budget B. Bobbi seconds. 4 for proposal B.
- 4 abstained.

Budget B passes and will be sent out to meetings by Barbara. Approval vote comes during May Intergroup meeting.

Meeting Updates: No time to update.

Next Intergroup Meeting: Saturday, May 28, 2022, at 11:15 a.m. after the Celtic Cross OA meeting.

Voices of Recovery and For Today were read. Third Step Prayer was said. Pamalar adjourned the meeting at 1:28 p.m.
