Pina B., webmaster: Not present.

Old Business:

- 1. Open. Review possible donations to WSO/Region 5 from excess funds. Lots of discussion on this item, which was tabled in September and discussed at length at this November meeting, with the feeling that groups should have a say on what to do with the excess funds.
 - Lynn H: We should hold a prudent reserve for in-person meeting obligations i.e. rent and office expenses, phone, internet access in office. Treasurer will need new software from Quickbooks. Not sure how much money should be reserved. We have money in savings to pay for our office. Some excess in checking (\$16,000) to donate to WSO. Safely, \$5,000 (maximum) could be contributed somewhere. Discussion? Take back to meetings?
 - Susie Y.: This is a conundrum we ask people to say where they want the money allocated, some don't, so it ends up in Intergroup money. If they wanted it divided with Region 5, they would have designated that. People might be upset about doing that. We want to avoid controversy.
 - Lynn: Is it right for us to give to WSO or Region or just hold on to it? What do
 other intergroups do? A standard? Maybe donate \$500 to each and increase in
 spring. Then contributors would not think we used their money in the wrong
 way.
 - Judy suggested asking people to talk to group members to designate monies they donate. Judy volunteered to contact Region 5 treasurer to see if there is a need. Judy polled those present. Some advocated a 60%, 30%, 10% split if it comes from groups. Lynn says there is no structure to do this.
 - Carol U: Suggested telling people about the 60, 30, 10 split by putting it on the

- website so all have the choice.
- Judy tabled this until January, after it was suggested a letter be sent to all groups for input. We need more info. A letter composed by Lynn will be assessed at the Jan. meeting before distribution and then meeting reps will report back to Intergroup.

New Business:

- **1.** Open: Need new person to assume responsibility for the Helpline. Also open: bylaws (Judy put this on hold). Susie suggested publicizing in Loveline.
- 2. Open: Revisit the idea of adding those willing to take calls to the speakers list. Pina was checking on logistics and security; Judy says bylaws has nothing on this.
